






3 versions (A, B, C) of educational programmes lasting from 45 minutes to 3 hours.




23 events and 641young people **2018:**

#### **UNIVERSITIES**




We are training two interns per university semester as a part of their undergraduate study.


#### 2018 Cyber Bullying


# NATIONAL ONLINE CAMPAIGNS

#### **YOUTH CAMPS**


Together with the Institute for Youth - IUVENTA, we have organised a three day camp for students/pupils. The camp was organised for participants of the Human Rights Olympic Games.

Within the programme, we offer youth organisations with free premises to organise their events (conferences, seminars, workshops etc), assistance in designing and developing their projects as well as other consultation services.














### NATIONAL FOCAL POINT ON BUSINESS AND HUMAN RIGHTS
